<p><b>Discussion on how the AONB’s work will support the delivery of Defra’s 25-year environment plan through the AONB management plan, core &amp; project work.</b> Discussion papers attached to the minutes for reference.</p> <p><b>EH: 1.</b> AONB Planning Officer should meet with newly appointed local authority planners and discuss best practice for working with the AONB. <b>2.</b> The AONB 2019-2024 Delivery Plan should include an extra column showing how it relates to Defra’s 25-year Environment Plan.</p> <p><b>JG: 1.</b> Agreed to join any groups discussing woodland activity. <b>2.</b> Column needs to be added to the paper to include villages &amp; settlements as these are an important part of the landscape.</p> <p><b>MW:</b> How to attract funding for all the projects needs to be included in the plan.</p> <p><b>Ecosystem Approach paper:</b> A subgroup including TY, LT, EH, BP &amp; DNW looked at the ecosystem approach within the AONB Partnership and as part of this outlined the natural capital we have in the AONB and what we know about it. This will then inform the 2019-2024 AONB Management Plan.</p>

<p><b>Minutes</b> The minutes were signed by the acting chairman as a true record.</p> <p><b>Matters arising</b> <b>4 EH</b> can provide written articles/blog for the new AONB website when prompted by the AONB Communications Officer. An amendment to the minutes were noted: <b>6.2 EH:</b> amendment to read; Ferne Animal Sanctuary is to provide access to their land for Natural England to carry out surveys on Great Crested Newts.</p>	<p>CG JV</p>
<p><b>ITEM 4 State of the Blackdown Hills Report</b> Report circulated prior to the meeting</p>	
<p>The report was drafted by the Somerset Environmental Record Centre and will be used as a starting point to identify key trends in data and as a result, changes to policies/ targets required in the 2019-2024 AONB Management Plan. It also provides a summary of progress against indicators in the current management plan (2014-2019). The following points were noted:</p> <p><b>JT</b> questioned the statement that only 3% of land within the AONB is accessible to the public. It was explained that these figures only represent the land covered by nature reserves, National Trust sites, Forestry Commission land and open access land and not rights of way paths. <b>EH:</b> Numbers on accessible land do not give a true indication on their own and further information such as the potential land available and comparisons to other areas are needed to understand the context for the figures. Baseline figures are needed. Offered support in putting data together. <b>LT:</b> In the past Natural England have provided data for free to AONB’s but there is now proposed to be a charge. <b>FR</b> is chair of the scrutiny committee at Mid Devon District Council and Neil Parish MP is questioned as part of the committee meeting. If members have relevant questions that they would like asked to Neil Parish please email them to <b>FR</b>.</p> <p><b>ACTION: EH to email FR with question on why Natural England no longer provide free data and why the 34 AONB’s in England should now pay for this information.</b></p> <p><b>EH:</b> We cannot manage change without data; can it be obtained from any other source? <b>SL:</b> National Trust has lots of data and is willing to share this with the AONB.</p> <p><b>ACTION: TY to contact SL about the sharing of data.</b></p> <p><b>GL:</b> Two measures have no readily available data 1. Number of affordable homes 2. Broadband speeds. Information can be provided for these from local authorities (1) and Connecting Devon &amp; Somerset (2).</p>	<p>ALL EH TY/SL</p>

<p><b>5.1 AONB Team report</b> (Report circulated prior to the meeting)</p>	
<p>TY gave a presentation on the work of the AONB team; presentation is attached to the minutes for reference.</p> <p>PC congratulated the team on a good portfolio of projects.</p> <p>JT asked how the team were coping with the amount of work for such a small team. TY noted the point and explained that not all projects were led/ administered by the AONB, for example the Facilitation Fund is administered by the Butterfly Conservation team and the project is facilitated by Gavin Saunders. If successful with the Culm Interreg bid a team will be employed to run the project.</p> <p><b>Blackborough House planning application update: BN, TY &amp; LT met on 4<sup>th</sup> July to discuss 2 areas relating to the application:</b></p> <ol style="list-style-type: none"> <li>1. Content - BN felt that the AONB written response to the application did not give enough of an opportunity for the developer to provide an updated submission</li> <li>2. Process – BN made recommendations regarding elements of the consultation process that can be considered as part of the review into the Partnership Management Group’s Terms of Reference due to take place before November’s meeting.</li> </ol>

<p><b>Review of Protected Landscapes</b> is being led by Julian Glover. Howard Davies, CEO NAAONB has met with Julian Glover to discuss the content of the review.</p> <p><b>NAAONB Conference</b> is being held from 24<sup>th</sup> – 26<sup>th</sup> July in Canterbury, <b>TY, BP &amp; CG</b> are attending on behalf of the Blackdown Hills AONB.</p> <p><b>ACTION: CG to share information on the conference with the Management Group</b></p>	<p><b>CG</b></p>
<p><b>6.3 Making it Local programme update</b></p>	
<p>Funding of £176K is available of which £96K has an expression of interest, £52K was allocated at the last meeting leaving £28K still available for projects. Contact Linda Wilson at Making it Local for more information.</p>	
<p><b>6.4 Briefings from partners</b></p>	
<p><b>John Greenshields:</b> National Trust (<b>NT</b>) has appointed a new community fund raising &amp; engagement officer for the Wellington Monument project called Emma Jones. NT are headlining the monument restoration project this year to raise the profile and obtain funding for the work.</p> <p>Woodland Assoc. is working with the AONB on the Facilitation Fund. Blackdown Hills Trust is grazing 160 Longhorn cattle on Blackdown Hills sites; the cattle were part of the Forestry Commission Neroche project.</p> <p><b>Donna Gowler:</b> Natural England are processing Countryside Stewardship applications that have a January 2019 start date.</p> <p>There is an issue with payments on the agri-environment schemes and they are currently working on end 2017 schemes.</p> <p>In future all agri-environment schemes are going to be administered through the Rural Payments Agency (<b>RPA</b>) and therefore some Natural England staff are expected to move to the RPA.</p> <p><b>Simon Larkins:</b> Various bids have been submitted for funding for the Wellington Monument restoration project and are awaiting a response.</p> <p>NT needs to raise £4M for restoration work on the monument of which £2M has already been raised and it is hoped a further £1M will be raised this year. Next spring improvements will be made to the car park with the possibility of a mobile catering unit being located on the site to bring in income.</p> <p><b>Peter Chamberlain:</b> DCC are working with the AONB on the Historic England &amp; Catchment projects and the Landscape Character Assessment review.</p> <p>A free photographic exhibition of the floods of 1968 (including Otterhead Lakes) will be on display at Kennaway House, Sidmouth on 7<sup>th</sup> &amp; 8<sup>th</sup> July.</p> <p><b>Cllr Bob Nelson:</b> Enquired on the progress of the Apple Trail, an external project mentioned at a previous meeting. <b>HS</b> advised that the project is looking for funding.</p> <p><b>Cllr John Thorne:</b> An attempt to change the name of the Blackdown &amp; Neroche wards to Neroche &amp; Wellington East was unsuccessful.</p> <p>No properties in Somerset have yet been connected to faster broadband as part of the CDS phase 2 project.</p>	

**Heather Stallard:** In 2008 the BHBA took a lease out on buildings on the Dunkeswell Airfield industrial site and turned them in to low cost business units for rent. Congratulations go to Richard Evans who has kept the units occupied for 10 years.

The Blackdown Hills Business Association marquee will be at the Honiton Show on Thursday 2nd August.

The previous Blackdown Artisan Trail will be run again next year but called the Blackdown Experience and will incorporate a range of things to do as well as artisan businesses.

**Cllr Graham Long:** Churchinford, Churchstanton & Clayhidon have now been connected by Gigaclear to superfast broadband.

Update given on the seven recommendations made by the Devon County Council scrutiny committee on the Connecting Devon & Somerset contract These recommendations were rejected by Connecting Devon & Somerset.

**Cllr Dave Durdan:** Taunton Deane BC and West Somerset DC have now merged and a shadow board has been set up with a chair and vice chair appointed. New boundaries will be announced in October and 20% of officer posts will be lost. The local boundary consultation has started and details can be found at

**Cllr Martin Wale:** South Somerset District Council are going through a transformation and funding for the AONB could be more difficult in the future.

**Elaine Hayes:** The National Lottery has awarded £8,700 to Ferne Animal Sanctuary for a new natural heritage project that aims to educate and inspire. 'Discovering Dragonflies' launches on 22nd July with a day of activities at Ferne Animal Sanctuary, near Chard. Major building project will start in the Autumn to improve the agricultural infrastructure at Ferne.

Two beehives have been established at Ferne and **EH** suggested to **HS** that these could be part of the Blackdown Experience event next year.

**EH** offered to display AONB promotional leaflets at Ferne's events.

**Cllr Frank Rosamond:** With the absence of a 5-year land supply policy at Mid Devon District Council there are speculative planning applications being submitted within the AONB.

**Charlotte Russell (by email):** Hembury Hillfort site is no longer at risk and has new interpretation signage. Heritage England(HE) funded repairs and improvements to the access track to enable future management and the site has been nominated for a Heritage Angels award.

The fabric of Dunkeswell Abbey has been secured with a substantial grant from HE and the building has been removed from the heritage at risk register. The archaeology remains at risk from decay.

Trickey Warren air field improved with substantial grant from HE, the landowners continue to keep on top of the vegetation management so that the fighter pens etc are no longer at risk.

A solution for the watch office and control tower have not been found

Stockland Great camp; attempts are being made to offer a grant to improve this at-risk site.

Casework reports regarding issues at Beckford Bridge were attended by HE Inspector and issues resolved with county highways.

<p>The appointment of a new building conservation project officer at Taunton Deane with support form HE capacity building grant is proving successful. The remit includes some support for the Wellington monument.</p> <p>Several applications for countryside stewardship have been received for sites at risk in the AONB and HE are pursuing means to improve these sites with stewardship grants.</p> <p>HE has been engaging in the AONB field boundaries pilot project at steering group level.</p> <p><b>Bruce Payne (by email):</b> Good attendance at the Community Nature Projects network meeting which is a great example of the Natural Futures legacy and highlights the ongoing need to support and provide guidance to local projects especially with volunteering recruitment and retention.</p> <p>Ongoing member of the Nature &amp; Wellbeing steering Group and the Culm Community Crayfish steering Group.</p>
